Important: TEACH Grants will be awarded to eligible students for the 2019-2020 school year. Eligibility and award is based on term enrollment. Students will be reviewed every term to ensure GPA and program eligibility. This form must be received in our office at least 30 days prior to your last date of enrollment during the 2019-2020 academic year.

**Directions:** Complete this form to be considered for the federal Teacher Education Assistance for College and Higher Education (TEACH) Grant program. The TEACH Grant provides up to \$4,000 per year (\$16,000 total for 4-year undergraduate programs and \$8,000 total for graduate programs) in grants to students who commit to:

- 1. Teach full-time;
- 2. Teach in high-need subject areas;
